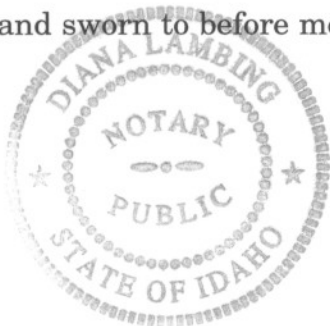


# DECLARATION OF CANDIDACY
